The world keeps shifting. Our resolve stands strong.

In 2025, the challenges didn't ease; they evolved. The crisis in Israel persisted, and hostages remained in captivity. Antisemitism continued to stain our city and greater world with brazen hate. New Yorkers still struggled with poverty and hunger. And other threats arose, like a new war between Israel and Iran. But through it all, UJA never wavered. And that's because of you.

It's your clear-eyed recognition of the critical issues at hand, and your ongoing generosity, that helps us confront the crises before us.

How you helped us help others.

Our overall allocation to support the people and land of Israel since October 7 reached nearly \$300 million.* This funding equipped hospitals, supported hostage families, provided mental health treatment to the bereaved, and so much more. At the same time, we stood strong on the front lines against antisemitism as we met the needs of New Yorkers struggling with rising expenses and the relentless grip of poverty, Holocaust survivors, and other vulnerable people who regularly depend on us for support. We also renewed our commitment to strengthen Jewish life and create more opportunities for Jewish engagement and Jewish pride.

Your continuing generosity makes all this, and so much more, possible.

A community like no other.

The King David Society (KDS) is a community of our most dedicated supporters, who make an annual gift of \$25,000 or more to UJA.

KDS members join us for high-level briefings and exclusive cultural events. They get VIP access to timely conversations with thought leaders and politicians. And they travel on missions both locally and abroad to experience the impact of their support.

This past year, we explored the complex reality of post-October 7 Israel through the perspectives of former hostages and their families, and Israeli photojournalist Ziv Koren. We also traveled to Israel to support survivors of October 7, meet with civic leaders and trauma specialists, and visit UJA partners responding to urgent needs on the ground.

We heard from Dr. Ali Rashid Al Nuami, the most senior foreign policy advisor to the president of the United Arab Emirates, about the UAE's relationship to Israel and world Jewry, and from Larry A. Silverstein about his new book detailing his 20-year battle to rebuild the World Trade Center. We hosted *Art Up Nation*, a unique exhibition of 60 leading Israeli artists showcasing their work in New York, and took exclusive tours of exhibits like *Ann Frank the Exhibition* and *The Book of Esther in the Age of Rembrandt*.

We marked holidays like Rosh Hashanah and Thanksgiving through volunteering with Afya and at Met Council, and we enjoyed a lively pre-Passover seder with Holocaust survivors.
