The past few years have brought immense challenges, and 2022 was no exception. From the lingering toll of the pandemic to war in Ukraine, from continued acts of antisemitism and horrific gun violence to rising inflation and economic uncertainty that's leaving no one untouched — we've weathered significant storms thanks to your support. Your ongoing generosity and determined resolve to help those in need will continue to fuel our responses to the crises before us,

How you helped us help others.

When war in Ukraine broke out in February 2022, it sparked overwhelming need for humanitarian relief. UJA has responded by allocating more than \$20 million in emergency grants to deliver food, medicine, and other vital supplies to those in war-torn areas of Ukraine; facilitate aliyah for refugees seeking shelter in Israel and support of these new immigrants once they arrive; and support of refugees in bordering countries and those who are making their way to New York. At the same time, we're continuing to help uplift the lives of those in poverty and dire financial straits after the height of the pandemic through our neighborhood hubs in areas of dense poverty, where people can find an array of services under one roof to help them support themselves and their families. We're confronting the mental health epidemic that's especially affecting young people by increasing funding for psychologists and mental health training at JCCs, camps, day schools, and social service providers.

And we're standing up to all forms of hate and strengthening security for institutions at risk of being targeted. Your continuing generosity makes all this, and so much more, possible.
